1. Introduction

- 1.1. Since the main agenda report was prepared, further consultation with Environmental Health has taken place in respect of additional information requested from and duly provided by the agent relating to lighting matters associated with the development.
- 1.2. This update provides Members with details of that additional dialogue and details relevant to the consideration of the application by the Committee.

2. Recommendation(s)

That the development be approved subject to the conditions and informatives as set out in the main agenda report, as well as with the addition of further conditions.

3. Information

- 3.1. At the time of the main agenda report being written and as set out in page 10 of the main agenda, insufficient information had been provided pertaining to lighting matters with the additional information required having been requested from the agent.
- 3.2. An amended lighting design plan was provided along with lighting design calculations, lighting survey plan and lighting specifications. A tree identification plan was also provided with an amended arboricultural impact assessment.
- 3.3. The lighting information provided was assessed and following the receipt of further information in respect of it, Environmental Health Officers have commented no objections. This was based on the information provided along with confirmation from the agent that the lighting would be in use between dusk and 22:30 hours as well as the height of the lamp posts not exceeding 5m above ground level.
- 3.4. With regards to the arboricultural information provided, this has been assessed by the Tree Officer who has reiterated his previous comments as covered by Conditions 3 and 4 as set out in the main agenda report.
- 3.5. On the basis of these comments the following are recommended:
- 3.6. Condition 2 as detailed in the main agenda report be amended to include the additional and amended documents provided.

- 3.7. An additional condition be attached specifying that the external lighting approved shall only be used between the hours of dusk and 22:30 hours in the interest of visual amenity.
- 3.8. An additional condition be attached specifying that the height of the lamp posts shall not exceed 5m above ground level in the interest of visual amenity.
