1. Background

- 1.1 In accordance with the Local Government Act 1972, there is a requirement on the Authority to designate three Statutory Officers: Head of Paid Service, Monitoring Officer and Section 151 Officer / Chief Finance Officer.
- 1.2 The latter is required to be a suitably qualified individual. The Section 151 Officer, along with the Head of Paid Service and the Monitoring Officer combine to form the Council's Statutory Officer functions. These roles are key to ensuring lawfulness, fairness, probity and general good governance that support the Council in achieving its aims. It is important that they work effectively together yet maintain appropriate independence.
- 1.3 Since the implementation of a new organisational structure, alongside the adoption of the Council's Corporate Plan on 1 April 2019, the role of Section 151 Officer has been performed on an interim basis by the Deputy Chief Executive (formerly the Director of Finance and Transformation).
- 1.4 In May 2019, the Council began a recruitment exercise for the position of Chief Finance Officer, with the intention that the successful candidate would undertake the duties of Section 151 Officer.
- 1.3 On 1 July 2019, an Appointments Panel was convened to interview shortlisted candidates. As a result of this process, Clive Mason was successfully appointed to the role, and is due to commence employment with the authority on 14 October 2019.
- 1.4 It is a requirement under the Council's Constitution that appointments to the three statutory posts (Head of Paid Service, Section 151 Officer and Monitoring Officer) are confirmed by the relevant Committee.
- 1.5 Clive Mason possesses the necessary experience, expertise and professional qualifications to undertake the statutory role of Section 151 Officer and it is recommended that Council formally confirms his appointment.

2. The Role and Duties of the Section 151 Officer

2.1 According to the Chartered Institute of Public Finance and Accountancy (CIPFA), there are five key areas critical to the achievement of a Chief Finance Officer's statutory responsibilities:

- maintaining strong financial management underpinned by effective financial controls;
- contributing to corporate management and leadership;
- supporting and advising democratically elected representatives;
- supporting and advising Officers in their operational roles; and
- leading and managing an effective and responsive financial service.

3. Other Implications

3.1 Once approved, the Council's Constitution will be reviewed by the Monitoring Officer and amended as appropriate to ensure the power to deal with financial matters that are the statutory responsibility of the Section 151 Officer are accurately referred to in the Constitution.

Review of Polling Districts and Polling Places (September 2019)

Purpose of Report:	To advise the Council on the final arrangements being proposed by the (Acting) Returning Officer for the Harborough Constituency in respect of the polling districts and polling places to be used at all relevant future elections and referendums that take place within the Borough.
Report Summary:	It is proposed that the existing polling arrangements for the Borough of Oadby and Wigston should be retained, with the exception of polling districts 'M' (All Saints) and 'Q' (South Wigston) where external factors have made venue changes necessary.
	The next scheduled election to take place within the Borough is the Leicestershire Police and Crime Commissioner election on Thursday 7 May 2020. Any changes to the existing polling arrangements agreed by the Council will be implemented in time for this election.

1. Background Information

- 1.1 The Electoral Registration and Administration Act 2013 amended the Representation of the People Act 1983 by including a new provision altering the timing of compulsory reviews of Parliamentary polling districts and polling places. The change meant that all local authorities have a duty to complete a compulsory review of their polling districts and polling places every five years. The aim of this was to reflect the move to fixed-term Parliaments and to ensure that all polling places had been reviewed in time for a Parliamentary election.
- 1.2 Whilst the legislative changes outlined at 1.1 above were aimed to coincide with the Parliamentary election originally scheduled for May 2020, this is now out of sync due to the snap Parliamentary election held in June 2017.
- 1.3 The Council's polling districts and polling places were last compulsorily reviewed in 2013. Once a compulsory review is completed, subsequent compulsory reviews must be started and completed within the period of 16 months that starts on 1 October of every fifth year after 1 October 2013. An optional interim review was carried out in July 2018 in preparation for the May 2019 Borough Council elections, however this did not replace the need for a further statutory review to be conducted between 1 October 2018 and 31 January 2020 (inclusive). That said, on the basis that the July 2018 interim review considered and addressed the long-term suitability of polling arrangements appropriately at that time, the proposals arising from the statutory review are minimal.
- 1.4 The current polling arrangements within the Borough are predominantly satisfactory and have been shown at numerous elections conducted in recent years to be practicable given the circumstances that prevail within the areas that they serve. The approach throughout this review has been to only propose changes where a clear conclusion has been reached that the new arrangements will:
 - Better serve the affected electors by offering superior polling facilities, accessibility

- and/or location in comparison with existing arrangements; and/or
- Reduce inconvenience caused by polling day arrangements for local residents without any substantive detrimental effect upon the voting arrangements for affected electors.

2. Terminology

- Polling District: The area created by the division of a constituency, ward or European Parliamentary electoral region into smaller parts, within which a polling place can be determined, which is convenient to electors. In Oadby & Wigston, each Borough ward is divided into a number of polling districts which each have an alphabetical code running from 'A' to 'S', based on the ward in which they are located.
- 2.2 **Polling Place:** The building or area in which polling stations will be selected by the (Acting) Returning Officer. A polling place within a polling district must be designated so that polling stations are within easy reach of all electors from across the polling district.
- 2.3 **Polling Station:** The room or area within the polling place where voting takes place.
- 2.4 It should be noted that the terms 'polling place' and 'polling station' are often used interchangeably and most people consider the polling place (such as a community centre) to be the polling station. However, it is possible to have more than one polling station per polling place (i.e. a double polling station) and this is the case in several polling districts in Oadby & Wigston with a large number of electors.

3. Consultation and Engagement

- 3.1 Public notice of the review, which invited representations to be made regarding the existing polling arrangements within the Borough, was published and displayed at the Station Road Council Offices and Bell Street Customer Service Centre on 24 July 2019. In addition, a copy of the review notice was placed on the Council's website and electronic copies were sent to:
 - All 26 Oadby & Wigston Borough Councillors (including the 6 Leicestershire County Councillors representing the Oadby & Wigston County Divisions);
 - The Member of Parliament for the Harborough constituency;
 - The 5 MEPs serving the East Midlands Region;
 - Political Parties with known contact details operating within the Harborough constituency; and
 - Organisations operating within Oadby & Wigston having knowledge of, or special expertise in, access for persons with different disabilities.
- 3.2 The initial proposals of the (Acting) Returning Officer (as set out in **Appendix 1** to this report) were received on 23 July 2019 and had to be published within 30 days of receipt. The proposals were published at the Council Offices, the Customer Service Centre and on the Council's website on 24 July 2019.
- 3.3 The only revisions proposed by the Returning Officer to the existing arrangements were:
 - Polling District 'M' (Wigston All Saints) Relocation of the designated polling place from Horsewell Lane Pavilion (now demolished) to the adjacent, recently completed Thythorn Hill Community & Sports Centre; and
 - **Polling District 'Q' (South Wigston)** After the temporary designation of St Mary's Parish Church Hall, Countesthorpe Road for the May 2019 elections, revert back to the designation of Bassett Community Centre, Bassett Street, following its return to use.
- 3.4 No formal written representations either in support or against the Returning Officer's proposals were received during the consultation period. A verbal representation was

received from Age UK, asking the Returning Officer to consider using its Hawthorn Centre facility on Paddock Street, Wigston instead of, or in addition to, The Elms and Ex-Services Social Club. Whilst there have been no reported issues from staff or voters in relation to The Elms to suggest that a change of venue is desirable, it is noted that the facility on Paddock Street provides a viable backup option in the event of The Elms being unavailable at any particular election.

4. Reasons for Recommendations

4.1 Following the review, it is submitted to Council that the needs of affected electors will be best met at future elections and referendums within the Borough by adopting the proposed changes to polling arrangements detailed within **Appendix 2**.

5. Implementation

- 5.1 The polling districts and polling places as approved by Council will be used for the Leicestershire Police and Crime Commissioner election on Thursday 7 May 2020 and any by-elections or Borough-wide elections/referendums called before the next statutory review of polling districts and polling places takes place.
- 5.2 If any approved polling place becomes unavailable before an election, the polling place can be changed by the Council in accordance with its decision-making arrangements. Under the Council's Constitution, it is a function of Full Council to make decisions concerning electoral wards, therefore any further changes to the arrangements proposed within the report shall be brought back before Council for approval.

6. Financial Implications

The Council is only responsible for the costs of conducting Borough Council elections, including when held, local by-elections that elect the Borough's own Councillors. At all other elections, all 'actual and necessary' costs, including hire fees for polling venues, are recovered by the Returning Officer from the relevant governing body for that particular election (e.g. Central Government for UK Parliamentary elections).

7. Legal Implications

- 7.1 In carrying out any review of polling arrangements, the local authority must comply with the steps set out in Schedule A1 Representation of the People Act 1983.
- 7.2 By approving the outcomes of this review the Council will be complying with its statutory duty to keep under review its polling districts and polling places as designated under the Representation of the People Act 1983 section 18A-18E (amended by section 17 of the Electoral Registration and Administration Act 2013).
- 7.3 Rule 20(1)(a) of The Local Elections (Principal Areas) (England and Wales Rules 2006), provides that the Returning Officer may use, free of charge, for the purpose of taking the poll, any room in a school maintained or assisted by the local authority, or in a school in respect of which grants are made out of monies provided by Parliament to the person or body responsible for the management of the school.
- 7.4 Following the conclusion of the local authority's review, certain persons have a right to make representations to the Electoral Commission. There are only two grounds on which a representation may be made. These are if:
 - The local authority has failed to meet the reasonable requirements of electors in the constituency; and/or

• The local authority has failed to take sufficient account of accessibility to disabled persons of the polling station(s) within a polling place.

Representations based on any other premise will not be considered.

7.5 Provision is contained within Section 18E RPA 1983 to state that no election is to be questioned by reason of any informality relative to polling districts and polling places.

Polling District N1 & N2:

A verbal representation was received from Age UK Wigston, requesting that the Returning Officer consider the use of its Hawthorn Centre facility on Paddock Street as a polling place.

Returning Officer Comments:

The Elms & Ex-Services Social Club has been used for a considerable number of elections and whilst its facilities are relatively modest, there has not been any feedback from voters or staff employed at the station to suggest that any significant issues exist. Therefore, there would need to be evidence that the Age UK facility would offer superior polling facilities and improved convenience for voters in order to make a compelling case for change.

Paddock Street is located at the far north of the polling district, some distance away from the largest centre of population on the Little Hill estate. The Elms is situated centrally in the polling district, which makes it more accessible for the majority of electors both to the north of Moat Street and the south of Bushloe End. In addition, Paddock Street operates a one-way system, so most electors travelling by car would be required to make an extended journey around Moat Street and Bull Head Street in order to cast their vote. Furthermore, although Paddock Street has a good sized car park, arrangements would need to be made on polling day to ensure that spaces accessible to the Hawthorn Centre entrance would be kept free for voters, rather than occupied by town centre shoppers.

On the basis of the above, it is not considered desirable to change the designated polling place for polling districts N1 & N2 to the Hawthorn Centre, however it does meet the criteria for use as a backup option, should The Elms be unavailable for use at any particular election.

That the Head of Law and Democracy / Monitoring Officer be given delegated authority to grant individual exemptions to the Street Trading Policy to facilitate community/not-for-profit or charitable events for a period not exceeding 24-hours in streets that would otherwise be consent streets, following consultation with the Chief Executive and Ward Members.

1. Background

- 1.1 In March 2009 the Council adopted a Street Trading policy, the main purpose of which is to prevent uncontrolled trading in streets within the Borough.
- 1.2 The Council adopted a scheme that comprises of 'Prohibited Streets' and 'Consent Streets'. In prohibited streets there is a general ban on street trading and for the purposes of the policy those streets are identified as follows:
 - A6 Leicester Road, Harborough Road and Glen Road, Oadby
 - A5199 Leicester Road, Bull Head Street and Welford Road, Wigston (excluding the layby at grid reference 6103 9775)
 - B582 St Thomas Road, Blaby Road (between its junction with Canal Street and its junction with Station Road), Station Road, Bushloe End and Moat Street, Oadby Road, Wigston and Wigston Road and London Road, Oadby
 - A563 Palmerston Way, Oadby
 - B667 New Street, Stoughton Road and Gartree Road, Oadby
 - B5418 Aylestone Lane and Paddock Street and Wakes Road, Wigston
 - B5366 Saffron Road, Wigston
 - All those roads where a speed restriction of 40mph and above applies.
 - All those roads contained within the Oadby Hill Top and Meadowcourt Conservation Area.
- 1.3 All other streets within the Borough are designated as Consent Streets and, subject to the completion of the appropriate application process and payment of a fee, the Council may (but is not bound to) grant a consent if it considers it appropriate.

2. Reason for the Review

2.1 At the meeting of the Licensing and Regulatory Committee held on 6 June 2019, a Member raised concerns around the attendance of pedlars at the annual 'Christmas Capers' event in South Wigston where they were selling in the street in direct competition with other

stallholders present, and requested that the Head of Law and Democracy look into the issues.

- 2.2 As a result of undertaking that research the Head of Law and Democracy identified that the area in which the event takes place (Blaby Road, South Wigston) is in fact a prohibited street under the Street Trading policy where no trading is permitted.
- 2.3 It would therefore appear that all persons who have previously traded under the auspices of the Christmas Capers event have been trading unlawfully.

3. Policy Review Findings

- 3.1 As this breach in the policy occurs/has occurred in a prohibited street, the Council's options in addressing the issue are limited, namely to actively enforce the policy or to introduce an exemption to the policy because the event is deemed to be a community/not-for-profit or charitable event.
- 3.2 On a more general level, the review has identified that similar issues exist with the Christmas events in Wigston and Oadby town centres, albeit that there are more options to address those issues i.e.
 - (a) Insist that any street traders in attendance at a community/not-for-profit or charitable event fully comply with the policy including payment of the appropriate fee and fully enforce the policy; or
 - (b) Insist that any street traders in attendance at community/not for profit/charitable event fully comply with the with the policy excluding payment of the appropriate fee; or
 - (c) Introduce a total exemption to the policy where the event is deemed to be community/not for profit or charitable event.

4. Recommendations

4.1 On 5 September, Members of the Licensing and Regulatory Committee considered the following views and recommendations of the Head of Law and Democracy and unanimously recommended them to Full Council for approval.

5. Christmas Events -South Wigston, Wigston and Oadby

- 5.1. The Head of Law and Democracy is of the view that Members have a simple choice in so far as South Wigston is concerned, because the activity is currently unlawful. If Members wish the event to continue in its current format then they must amend the policy to permit that to happen. In reaching a decision Members are advised to have regard to other similar events that may be proposed in the future.
- 5.2. Insofar as Wigston and Oadby are concerned, the options outlined in paragraph 3.2 above (a and b) are considered to be onerous (both for the organisers of the events but also for Officers particularly if a fee exemption scheme is also introduced) and the Head of Law and Democracy proposes that any mechanism by which the policy can be suspended should apply equally across the Borough.
- 5.3. It is therefore proposed that Members approve the delegations set out above that authorise the Head of Law and Democracy to suspend the policy in a specified street (either a prohibited or consent street) for a period not exceeding 24 hours following consultation with the Chief Executive and Ward Members to facilitate community/not for profit and charitable

- events but that the delegation does not extend to permitting single street traders on what would otherwise be prohibited streets.
- 5.4. It is also proposed that Council approve a further delegation that authorises the Head of Law and Democracy to grant individual exemptions to the policy to facilitate community/not for profit or charitable events for a period not exceeding 24 hours in streets that would otherwise be consent streets following consultation with the Chief Executive and Ward Members.
