



Report Title:	Review of Membership of Council Bodies etc. (February 2023)
Report Author(s):	Samuel Ball (Legal & Democratic Services Manager / Deputy Monitoring Officer)
Purpose of Report:	Following a recent change to the political balance of the Council, it is obliged to review Member representation on the Committees, Sub- Committees, Boards, Panels, Forums and Working Groups of the Council ("Council Bodies") which it appoints to ensure that these reflect the make-up of the political groups on the Council as a whole.
Report Summary:	On 10 January 2023, Councillor Naveed Alam resigned from the Liberal Democrats and joined the Conservatives. This triggered a review of the Council's proportionality arrangements in relation to the eligible Member representation and allocation of seats on Council bodies. Reappointments to those affected Council Bodies by political group should now be made to reflect the Council's new political composition.

# **1.** Political Composition of the Council

- 1.1 On 10 January 2023, the Monitoring Officer was informed by Councillor Naveed Alam that, with immediate effect, he resigned from the Liberal Democrat Party and joined the Conservative Party and wished to form part of the Conservative political group on the Council. As a result, the political composition of the Council changed from 23 Liberal Democrats and 3 Conservatives to 22 Liberal Democrats and 4 Conservatives.
- 1.2 Consequently, a review of the Council's proportionality arrangements in relation to minimum eligible Member representation and allocation of seats on Council Bodies, was triggered, resulting in the Liberal Democrat political group now being entitled to 84.62% of seats of Council Bodies and the Conservative political group being entitled to 15.38%.
- 1.3 A full break down of the revised political balance of the Council, and its proportionality arrangements in terms of minimum eligible Member representation and allocation of seats on Council bodies, is reflected in the figurework set out at **Appendix 1** and **Appendix 2**.

# 2. Removal and Appointment of Members to Council Bodies

- 2.1 The revised political balance of the Council affects on the following Council Bodies:
  - 2.1.1. The Liberal Democrat political group **LOSE** one (1) seat on:
    - Policy, Finance and Development Committee
    - Development Control Committee
    - Place Shaping Working Group
  - 2.1.2. The Conservative political group **GAIN** one (1) seat on:
    - Policy, Finance and Development Committee
    - Development Control Committee
    - Place Shaping Working Group
  - 2.1.3. There is one (1) **VACANCY** for the Liberal Democrat political group on:
    - Service Delivery Committee
    - Children and Young Peoples' Forum

**Note:** These vacant seats are retained by the Liberal Democrats, and do not automatically transfer over with Councillor Alam to the Conservatives, otherwise there will be an over-representation of Conservative Members on Council Bodies.

2.2 At the time of publication of this report, the following nominations have been received, after consultation with each of Council's political party groups' leaders, for the removal and appointment of following Members from/to those affected Council Bodies accordingly.

2.3. Where a political group has declined to nominate a Member, that seat will be allocated against that political group as 'vacant' to maintain proportional allocation. Where a seat is awaiting confirmation and/or a nomination, these can be tabled at the meeting itself.

#### 3. Reappointment of Chairs to Council Bodies

3.1 At the Annual General Meeting of the Full Council on 10 May 2022, Councillor Alam was appointed the Chair of the following Council Bodies whilst, at the time, forming part Liberal Democrat political group:

- Children and Young Peoples' Forum
- Oadby Residents Forum
- 3.2 In light of the above, it is open to Council to resolve whether to retain Councillor Alam's current appointment(s) or to reappoint the Chair of the these Council Bodies.
- 3.3 If Council is so minded to re-appointment, at the time of publication of this report, the following nominations have been received, after consultation with each of Council's political party groups' leaders, to re-appoint the following Member(s) as Chairs.
