Title: Resident Forum Budget Position and Allocation Requests

1 Introduction

This report is to update members as to the financial position on the Local Residents Forums at 31 December 2014 and give an indication of the amount of unallocated balances.

2 Recommendations

- 1) That Members should note the position of the Forum's budget.
- 2) That members approve the allocation requested by the forums as set out below.

3 Information

The attached report (Appendix 1) shows the financial position for the three Local Residents Forums at 31 December 2014. The report shows the actual spend at the end of December for each scheme approved by the forums. Once a scheme is complete any under spend on that scheme is placed back into the spending pot for future allocation. Members should take note of the current position when considering requests for funding.

- 2) The South Wigston Residents Forum met on the 19 November 2014, at which it was requested that the Council purchase a mobile speed awareness sign, at a cost of £3,000, for use within South Wigston.
- 3) The Oadby Residents Forum met on the 20 November 2014 at which it was requested;
 - That a grant of £3,750 be made to Oadby Remembers to fund the first year of a three-year project commemorating the Oadby soldiers that died in the First

World War. The grant will fund exhibitions, promotional materials and the development of a website.

- ii) That the Council install a bench on Burtons corner at a total cost of £1,000
- 4) The Wigston Residents Forum met on the 24 November 2014, no requests for funding were submitted at this meeting.
- 5) Members should also note that the Council Priority Reserve containing £73,000 was set up with the intention of funding improvements in line with the main priorities of the Council, in consultation with the local resident's forums. This gives a potential spend for the forums of over £200,000. Reference to this is contained in the Overall General Fund Budget report Appendix 5 on this agenda.

Implications
