Breach of the Code of Conduct by Councillor Ravendra H Thakor

Purpose of Report:	To advise Members of the outcome of a Determination Sub- Committee held on 12 June 2018 into an alleged breach of the Code of Conduct by Councillor Ravendra H Thakor ("Cllr Thakor").

1. Background

- 1.1 On 01 November 2017, an Assessment Sub-Committee convened to consider an allegation that Cllr Thakor may have breached the Code of Conduct by releasing confidential information (an e-mail) that had come into his possession in his capacity as a Councillor and as a result of the release of that information, he had brought the Council into disrepute.
- 1.2 Having considered the information placed before them, the Members of the Assessment Sub-Committee resolved that the allegation was to be referred to the then Deputy Monitoring Officer (now the substantive Monitoring Officer) for investigation.
- 1.3 The Monitoring Officer determined that the investigation was best dealt with externally and, on 13 March 2018, instructed Mr Alex Lawrence, a solicitor employed by Anthony Collins Solicitors, to undertake an investigation on his behalf.

2. Investigation

- 2.1 Mr Lawrence completed his investigation on 29 May 2018.
- 2.2 Mr Lawrence found that, on the balance of probabilities, Cllr Thakor was:
 - 2.2.1 Acting in his capacity as a Councillor when he received the e-mail, and by extension, continued in that capacity when deciding how to use the information he had so obtained as a Councillor and that therefore, the Code applied.
 - 2.2.2. In breach of Rule 3.3 (Confidentiality) of the Code by leaking the e-mail.
 - 2.2.3. In breach of Rule 3.1 (Respect) by leaking the e-mail.
 - 2.2.4. In breach of Rule 3.5 (Reputation of the Authority) by leaking the e-mail.

3. Determination Sub-Committee

- 3.1 On 12 June 2018, the Monitoring Officer convened a Determination Sub-Committee meeting comprising of Councillors Mrs L M Broadley (Chair), Dr T K Khong and M L Darr to consider Mr Lawrence's report. Cllr Thakor failed to attend the hearing.
- 3.2 Having considered the report and the advice of the appointed Independent Person, Members of that Determination Sub-Committee unanimously accepted the report's findings and went on to consider what sanctions to impose, and determined that:
 - 3.2.1 Cllr Thakor be censured;
 - 3.2.2 The findings of the Determination Sub-Committee be reported to Full Council and published on the Council's website; and
 - 3.2.3 The Leader of the Oadby and Wigston Conservative Group be informed that the Sub-Committee recommends that Cllr Thakor be removed from Committees.

- 3.3 The Monitoring Officer wrote to Cllr Thakor on 19 June 2018, setting out the findings of the Determination Sub-Committee and enclosing a letter of censure from Cllr Broadley, as Chair, on behalf of the Council. The correspondence was copied to the Conservative Group Leader, Councillor B Dave. Notification of the breach of the Code was also published on the Council's website the same day.
- 3.4 On 26 June 2018, Cllr Dave advised the Monitoring Officer that he had considered the recommendation of the Determination Sub-Committee and advised Cllr Thakor that his committee appointments on behalf of the Conservative Group had been withdrawn until further notice.
