

## **Matters Arising from the Oadby Residents Forum meeting held on 20 February 2019**

### **Page 5:**

#### **Action: Complete**

An invitation was extended to the MP for Harborough, Oadby and Wigston to attend the next Oadby Residents' Forum meeting to, discuss housing development.

#### **Action: Complete**

Invite an officer from Planning Services to attend the next Oadby residents' Forum meeting to; provide a presentation on the Stoughton Grange building application, noting the implications on building, from the perspective of Education and the NHS East Leicestershire and Rutland Clinical Commissioning Group (CCG).

A briefing update addressing the most up to date position in relation to housing developments is to be provided for the Chair to share with residents.

### **Page 6:**

#### **Action: Complete**

The Chair will check with the Council if the ice cream trader outside of Beauchamp College has a licence with Oadby and Wigston Council to sell ice cream near to Beauchamp College.

The Council confirmed any trader of ice cream must have applied for a licence to trade in any part of the Borough. Anyone is at liberty to ask to see this licence.

### **Page 6:**

A request for a Bus Shelter opposite Waitrose on Harborough Road was rejected. This was due to the unacceptability of the depth of the pavement.

A request for a Bus Shelter to be placed in situ on the A6 near Highcroft Avenue, Oadby, was agreed.

A request for a Bus Shelter for the bus stop at Severn Road/Hursley Close, Oadby was rejected. The reason being the pavement is not wide enough for a shelter. The land is owned by Persimmon Homes. If entry is made on the land behind the shelter this might make the shelter a possibility, but currently the Council does not own this land. Hard standing would also be required and discussions for adoption of the land has stalled.

A request by a resident for the purchase of a bench in memoriam of a family member in principle is agreeable to the Council. The resident will pay for the bench and a plaque to be fixed to the bench. The resident must consult the neighbours to seek their agreement in writing to site the bench, as the Street Furniture Officer notes it may attract people to it who some of the households may not support being there.

In the past such installations have led to anti-social behaviour. The new bench costs £650 plus the cost of a plaque. The Council would fit it free of charge. The location identified for siting the bench is the junction of Fairstone Hill and Wickham Road, Oadby.

**Page 7:**

A request was made for the purchase and installation of a Litter Bin. The location identified is; Upland Road by Launde school bus stop.

The litterbin is on order and will be installed as soon as possible.

A request for the purchase and installation of a Litter Bin for the jetty/alleyway between Adlington Road and Launde Road was agreed. The alley way is heavily used by: dog walkers, school children from Brookside and Manor schools at the corner of Woodfield Road.
