## <u>ASB</u>

There are pockets of anti Social Behaviour in Wigston currently. This is predominantly groups of young people on Friday evenings. The beat team are currently tackling this by conducting dedicating patrols and working closely with youth workers.

## **Priorities**

To tackle and reduce vehicle crime & Burglary Non dwellings - various operations and initiatives running and are working with partnership agencies in order to tackle the problem.

## Crime prevention Advice

PC Paul White provided some seasonal advice regarding not leaving vehicles running on driveways unattended on frosty mornings, keeping valuable looking presents out of view when leaving them under the Christmas tree, and reminded residents that the police have a batch of number plate safety screws that can be collected or delivered if they email him.

#### Residents Concerns

Residents were reminded that if they belief a vehicle is obstructing the highway or access on a pavement that they should contact the police.

## 3 IMPROVING URGENT CARE SERVICES - REVIEW

Roz Lindridge and Emma Rogers, East Leicestershire and Rutland Clinical Commissioning Group (ELR CLG) outlined the case for the review of urgent care services.

Emma first outlined what ELR CLG were responsible for, that being Hospitals, Community healthcare, Mental health services and Managing prescribing, and what NHS England Area Team (Leicestershire and Lincolnshire) were responsible for (Local GP services, Dentists, Pharmacies, Ophthalmologists, Specialist services).

One of their key responsibilities for ELR CLG is to ensure good quality **urgent care** is available when patients need it.

Urgent care services deal with health conditions which are urgent, but are neither life-threatening nor emergencies, such as minor injuries and illnesses, and can be accessed without an appointment at hospitals, walk-in centres and GP surgeries. They might typically include, minor burns, cuts and wounds, skin complaints, rashes, minor injuries to the head, back, and shoulders, coughs, colds and flu-like symptoms, and constipation, vomiting and diarrhoea.

The purpose of urgent care services review is to ensure ELR CLG commission safe, timely, effective and value-for-money urgent care services that meet the needs of local people, and that they ease pressure on busy A&E services.

The case for change was set out as being that patients were confused about where to go for what service, variations in peoples' use of GPs' out-of-hours services, inconstant urgent care services. For those who use them urgent care at walk-in centres and minor injury/illness centres usually means shorter waiting times than A&E and they are highly valued, plus almost half of minor injury unit cases would have gone to A&E if the units had not been there.

Emma Rogers informed the meeting that their approach to the review would be to **analyse** current urgent care services, **assess** the need for urgent care services, **listen** and respond through public engagement, **identify** the options that best fit people's needs and **ensure** the options they come up with are consistent with other strategies.

The range of current urgent care services across East Leicestershire and Rutland were presented to the meeting, the Oadby & Wigston Walk-in Medical Centre was stated as being an 8am-8pm service, 365 days a year. Currently there was no uniformity of service so one of the options they would be looking at was providing a uniformed 7 day a week service across the whole area. Furthermore, urgent care services in the area are currently the responsibility of NHS England, but from April 2015 they will be the responsibility of ELR CCG. This includes urgent care services provided at the Oadby & Wigston Walk-in Medical Centre. Until NHS England's announcement, the 8-8 centre was not part of the ELR CCG plans. The meeting was assured that the purpose of the review was not to close the Oadby & Wigston Walk-in Medical Centre, but to maximise the potential of the service and ensure that the service provided best met the needs of the area. That included looking at the location.

The meeting was informed that the Oadby & Wigston Walk-in Medical Centre was highly used with 34,000 users, and that the views of local people will play an important part in helping the ELR CCG draft its options for a future service. People had so far told them that it was important to have services close to home, to be seen quickly by trained staff with the right equipment and to have adequate parking and good transport networks. Following this period of consultation proposals would be drawn up and full consultation on a number of options would take place between February and March 2014.

Further events during this consultation period were presented to the meeting, one event that was specifically on urgent care services would be taking place at:

Residents issues and proposals for the urgent care service:

- The lack of transport between Wigston and Oadby was seen as a barrier to residents in Wigston using the Oadby & Wigston Walk-in Medical Centre, and that travelling to the LRI is easier for those without transport.
- Wigston residents were assured that ELR CCG the location of the service would be considered, as well as co-locating services at other buildings in the area.
- Hard copies of the consultation document to be provided to those

5	Some notable achievements for the partnership:	
•	Joint Community Based Surveys: out of the seven Leicestershire districts Oadby & Wigston Borough came top for the percentage of residents that felt people using or dealing drugs, or being harassed or intimidated, was not a problem,	
•	Out of the seven Leicestershire districts Oadby & Wigston Borough was second with 84% of people agreeing that the police and other local services are successfully dealing with ASB and Crime,	
•	Domestic burglary down 15%, while Other Than Dwelling burglary was down 13.9%,	
•	ASB down 52.3% over the past 5 years (2415 incidents in 2008/9 compared to 1152 in 2012/13),	

	• Improved awareness and reporting of hate incidents/crime, numbers increased from 5 to 12 over the year, and	
	• 83.6% on Joint Community Based Survey feel police and other local services are successfully dealing with ASB and crime.

# 7 LEICESTERSHIRE COUNTY COUNCIL ISSUES

Juan Pardo (Community and Places Officer – Leicestershire County Council) had no pressing issues to raise with the forum.

A paper outlining the best ways for residents to raise issues regarding highways was distributed at the meeting. The methods ranged from phoning and email to post, though it was stressed that phoning was the most effective and that residents should make sure that they get a reference number, so if there is a query it can be chased up.

**Residents Issues:** 

- Wakes Road Roundabout. Meeting informed that they should be working by the end of the week, but there were concerns that this was a hotspot and what the police would be doing to maintain order. There were also questions regarding whether or not barriers would be erected back or not.
- Blocked drains along Bulls Head along by Aldi. These have been blocked for sometime. The meeting was advised that LCC no longer do scheduled checks and that if residents have such concerns that they should ring LCC and that they would be addressed.
- New GP service on Station Road. Questions regarding the right turn into the development and why there are no traffic controls.
- Paddock Street. Concerns that the requested pedestrian crossing has not been actioned.
- Concerns on the Little Hill Estate regarding cars parking on both sides of the road creating an obstruction. Issue to be reported to the Police.
- Concerns regarding the lack of publicity around the changes to the opening time of the waste site at Oadby. The meeting was informed that it was now closed on Thursday and Friday
- Their was also concerns regarding the lack of information from Leicestershire County Council regards cutting street lighting to a number of roads in the borough from mid-night, e.g. Penzance Avenue.

	A resident informed the meeting that the street lights around Moat Street/Long Street had gone again.	
	A resident pointed out that the Paddock Street Bus Shelter is a mess and that it required tidying up.	
	Bull Head/Moat Street Lights. Concerns that the sequencing of the lights make it dangerous, but their have been no recorded accidents so LCC has been unwilling to take notice.	
	The chair referred a number of the highways issues to the County Councillor Michael Charlesworth to take-up on behalf of residents.
