Introduction from all the members and a warm welcome to the Nick Tarry, from KL	
1. Minutes of previous meeting 28th October 2013 and outstanding actions	
It was agreed the minutes of the meeting on 28.10.13 were approved.	
 Cameras – SP and the Police are updating and improving the way the footage is being viewed. 'No Tools Left Overnight' stickers have been distributed SP working with Simon Adam in customising the capturing of ABS satisfaction and also making sentinel usage same 	

as the other borough.

2. Presentation from Dave Franks on Performance report

- Report is a snapshot of what the document covers
- Breakdown on figures shows an improvement in all crime in Oadby & Wigston area compared to rest of Leicestershire
- There has been a decrease in Domestic Burglary and Commercial Burglary,
- Theft from Motor vehicle (TFMV) was significantly up across the Force area including O&W
- Trackable asset has been successful and three arrests have been made.
- Cycle Theft is a big issue around university areas such as Loughborough and the data is generic.
- Violence against the Person with Injury has increased, one
 of the possibilities might be the good summer weather,
 however police are visiting all premises twice a year and
 hotspot are visited five times a year.
- General satisfaction figures pleasing, further work needed in few areas. Police & OWBC to look further at follow up processes

3. Swanswell Service Update by Stuart Haste

- Quarterly Treatment figures show increase in male treatment compared to female.
- Further breakdown in Ethnicity indicates White British group to be receiving the most treatment.
- There is a slight dip in alcohol treatment in OWBC and further monitoring to be carried out.
- Lack of young persons being referred
- Leaving the treatment system in a planned way has exceeded the target with a positive outcome.
- SH looking to set target dates for clients to exit treatment so clients are working towards specific date
- Move from Kennedy house to Bassett centre which is open 7 days a week, nurses available, GP's on site, drop in centre, and a café where the patients can relax and speak to the worker.
- No complaints or death in service has been reported.
- SP was concerned that Oadby has only one centre, SH informed that they will monitor areas, and if they notice an increase will be able to transfer staff to targeted area to deal with the situation.
- SD raised needle exchange at present in Oadby, SH is working to increase that provision across the Borough

4. Probation Update.

 MG updated the changes within probation as of the 1st April 2014

- Probation have split into two groups NPS And CRC
- NPS will be dealing with high risk case and CRC low & medium risk cases.
- Both NPS & CRC will be using two different IT systems.
- They will be temporarily be based at South Wigston.
- Representation from both groups will be needed to attend CSP meeting.
- Until all the teams are fully functional, MG will be the contact liaison between Probation and CSP.
- KL thanked MG for his contribution to the work of O&W CSP

5. Youth Service in O & W update

Penny Pugh gave an overview of recent YS changes

- All the moves have been completed and Early Help team has been formed.
- Teams to be based at Bassett Street and Oadby Library
- Work is changing significantly and more targeting of children and families in need will take place
- SP updated that OFSTED inspection was a positive and the Inspectors were impressed with the level of partnership working
- SLF now under Children & Families

6. Women's Aid Leicestershire Ltd Update.

 There was no representation at the meeting. Figures since received and circulated to members

7. Fire Brigade Update

- Rescue Service report informs that the performance measures in some incidents are below target.
- Actions have not been set as work in progress, NT to present these action to the next meeting
- Number of projects are taking place to address some of the issues
- Setting up fire Cadets along with OWBC
- Educating Children through school programme.
- Princess trust Schemes
- MC mentioned that Industrial action are going head with Fire Service, If OWBC went below 6 units it could be critical, negotiation are in place to avoid this situation.

8. Leicestershire County Council Update

- Domestic Homicide reviews still ongoing
- JF informed no new updates on ASB
- Hate Incident awareness week commencing 17 March 2014
- Respecting difference will be the theme
- New strategy for domestic abuse, focusing on prevention work will be one strand and sustainable support services for

victims

9. CSP Budget

- SP updated that funds are still available and requested partners to utilise the funds.
- SP and SB meeting to discuss where the funds can be used.

10. O&W Strategic Assessment

SP outlined the main points from the Strategic Assessment

- Increase in Shoplifting and Cycle theft.

- FB highlighted that this assessment gives information only to September 2013, and would for completing the bids.
